Investment Objective 投資目標

Haitong Global RMB Fixed Income Fund seeks long term capital growth and income in RMB terms by investing primarily in (i) fixed income and debt instruments; (ii) deposits; and (iii) collective investment schemes (collectively referred to as "Income Instruments"). The majority of the Income Instruments are (i) denominated in RMB and (ii) denominated in USD but are hedged back to RMB (collectively "RMB Exposure Income Instruments") which are issued or distributed outside mainland China. These may include but are not limited to, bills, notes, bonds, floating rate notes, deposits, negotiated deposits, money market instruments, certificates of deposit, commercial paper, exchangeable bonds and convertible bonds issued by issuers such as governments, government agencies, supranational entities, corporations, financial institutions and banks.

Manager's Comments 基金經理評論

In January 2026, Offshore RMB bond market rose overall, recording 0.45% month return. Among these, High yield bond performed the best with a monthly return of 0.69%. Investment grade bond rose 0.43% and Government bond slightly rose 0.27% this month. Meanwhile, 10y US Treasury yield moved up 9bp to 4.24%, 2y US Treasury yield moved up 6bp to 3.53%, while 10y Chinese Government Bond yield moved down 4bp to 1.81%, 2y Chinese Government Bond yield moved up 1bp to 1.37%.

At the FOMC meeting in January, the Federal Reserve decided to maintain the target federal funds rate range unchanged at 3.5% to 3.75%, declaring the end of the three continuous rate cuts from 2025. In the post-meeting press conference, Chair Powell emphasized that policy is "not significantly restrictive," and that decisions would remain data-dependent on a meeting-by-meeting basis with no preset course. The market began to turn down rate cut expectations in 2026. At the end of this month, President Trump nominated Kevin Warsh to succeed Powell as Federal Reserve Chair, sparking further market discussion and volatility regarding Fed independence and the future policy trajectory.

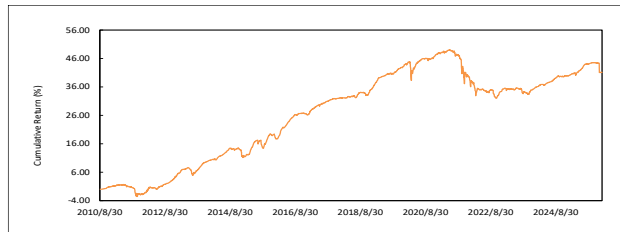
Considering the suspicion on Fed independence and the coming disturbance of geopolitical conflicts, both USD index and long-term treasury yield could become more volatile. At the same time, backed by solid fundamental and strong export, RMB keeps being appreciated over USD. In the foreseeable future, the mild appreciation process of RMB over USD will continue, and RMB assets will become more valued by risk averse investors. The offshore RMB bonds will also become more popular globally at the same time. We'll keep tracking the offshore fixed income market closely to find more investment opportunities in the coming days.

2026年1月份，離岸人民幣債券市場整體上漲，全月漲幅為0.45%。其中，高收益類債券表現最優，全月漲幅為0.69%，投資級債券全月漲幅為0.43%，政府類債券全月漲幅為0.27%。同期10年期美國國債收益率上行9bp至4.24%，2年期美國國債收益率上行6bp至3.53%，同期10年期中國國債收益率下行4bp至1.81%，2年期中國國債收益率上行1bp至1.37%。

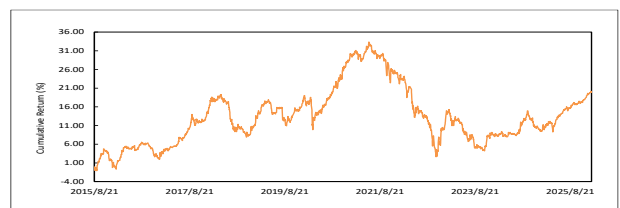
本月在FOMC會議上，美聯儲維持目標利率在3.5%至3.75%的區間不變，結束了2025年以來連續三次降息的週期。美聯儲主席鮑威爾在新聞發佈會上強調政策“並非顯著限制性”，決策將逐次會議資料依賴，無預設路徑。市場對2026年美聯儲的降息預期出現下修。同時美國總統特朗普於月末提名Kevin Warsh接替鮑威爾擔任美聯儲主席，引發市場對美聯儲獨立性和未來政策路徑的進一步擔憂。隨著市場對於美聯儲獨立性的擔憂和全球地緣衝突的持續加劇，美元指數和長端美債收益率可能出現進一步的波動。與此同時，人民幣則受益於國內穩定的經濟基本面和強勁的出口規模，保持着兌美元的持續升值。我們預計未來一段時間內，人民幣兌美元的匯率仍將保持溫和上漲的趨勢，人民幣資產作為全球避險資產的比重正逐步提升。在這種背景下，離岸人民幣債券的配置吸引力也將同步持續提升。未來我們將繼續緊密跟蹤離岸人民幣債券市場，尋找投資機會。
