Haitong Greater China Vision Fund aims to achieve capital growth through a portfolio of publicly quoted equity or equity-linked securities of companies based in or with the majority of their business conducted in or with substantial revenue derived from Greater China ("Greater China Companies"). "Greater China" includes the mainland China, Hong Kong, Macau and Taiwan.

海通大中華遠景基金旨在通過投資於總部設於大中華區或其大部分業務於大中華區進行或有大量收入來自大中華區的公司(「大中華區公司」)的公開報價股份或與公司股票掛鉤之證券的投資組合,以取得資本增值。「大中華區」包括中國內地、香港、澳門及台灣。




